Florida Chapter Annual Meeting Highlights

The 2018 Florida Chapter, American College of Surgeons Annual Meeting was held on April 6 and 7 at the Loews Sapphire Falls Resort in Orlando. This year's meeting had the highest attendance with nearly 140 attendees. The meeting would not have been such a success without the hard work of the Program Committee. This committee produced a wonderful program that encompassed a wide array of specialties, truly living up to the meeting's theme—"The Wide World of Surgery."

We were fortunate to have a prestigious lineup of faculty participate at the 2018 meeting. Speakers included Patricia Numann, MD, FACS, who spoke on mentorship as well as an adequate surgical workforce and Jay Redan, MD, FACS and Natalie H. Hall, DVM who gave a fascinating talk on minimally invasive surgery in zoo animals. We also had a timely discussion on disaster preparation from Joseph Ibrahim, MD, FACS.

Resident and Associate Society Update

The Florida Chapter of the American College of Surgeons (FCACS) has long made an effort to promote opportunities for the professional advancement of surgical trainees and associate members. Over the years, FCACS has been committed to engaging trainees and young faculty through the Resident and Associate Society (RAS). Traditionally, residents and associates elect their RAS representative at the conclusion of the Annual Meeting. The elected member, usually a junior or senior resident, is charged with a two-year commitment as chair-elect and later chair of the RAS-FCACS. The RAS-FCACS chairs are the voice of trainees and associate members in Florida. They represent the interests of RAS members to the FCACS Council while assisting with planning and coordinating Chapter functions geared towards, or involving, RAS Members.

In 2015, several residents ran for the chair-elect position at the Annual Meeting in Tampa. Seizing the opportunity, Jaime Membreno, MD, FACS, then Chapter President, proposed the formation of the RAS Committee, involving those who ran for chair-elect and members interested in participating. Ultimately, 15 enthusiastic

trainees from varied Florida surgical programs established the RAS Committee.

Over the past years, the RAS-FCACS has seen tremendous success thanks to strong participation and the support from Chapter leaders. We have seen a rise in both the quantity and quality of abstracts that residents, fellows, and medical students have submitted to the Edward M. Copeland, MD Resident Paper Competition. Each year, the top papers submitted to the FCACS Committee on Cancer (COC) Paper Competition and presented at the Annual Chapter Meeting represent the state of Florida at the ACS Clinical Congress. Over the past two years, Florida trainees have won second place (Ahsan Raza, MD, 2016) and first place (Kristina Go, MD, 2017) in the COC Paper Competition on the national stage. We are eager for this year's COC paper finalists, Danielle Henry, MD; Michael Gerber, MD and Anthony Ferrantella, MD, to compete in the 2018 competition. We have seen similar success with state winners in the Florida Committee on Trauma Paper Competition, which have placed well in the regional contest.

We see the RAS-FCACS as a pipeline to forming surgical leaders and representatives who have a vested interest in improving the practice of surgery in Florida.

Our trainees' robust academic performance is matched by their refined technical skill. Last year, Florida residents Sarah Eidelson, MD and Tyler Loftus, MD won the Inaugural ACS Skills Competition at the 2017 Clinical Congress. We look forward to seeing winners of the 2018 FCACS Skills Competition,

Christina Mesoraca, DO and Russell Hawkins, MD, compete in the 2018 ACS Skills Competition.

Understanding the importance of medical student involvement, past Chapter President Patricia Byers, MD, FACS called for the formation of the Medical Student Committee. Committee Chair and University of Miami medical student Tara M. Irani, JD, has successfully assembled a committee of student representatives from most medical schools in the state. This group has provided students with the opportunity to collaborate and strengthen their surgical interest groups at their respective schools. The group is also working to establish programs that attract young medical students to the surgical profession.

We see the RAS-FCACS as a pipeline to forming surgical leaders and representatives who have a vested interest in improving the practice of surgery in Florida. We must start early by engaging medical students in leadership activities so that when they become surgical trainees and later, board certified surgeons, they have the skills required to serve and represent the residents and visitors of the Sunshine State. It is our mission to continue to provide resources and mentorship to our trainees as they develop in the great profession of surgery to become state and national leaders.

With your support and the support of the FCACS leadership, this great task is certainly attainable. +

Advocacy Update

The Florida Chapter of the American College of Surgeons Advocacy Committee, Governors and Councilors continue to work tirelessly on Advocacy and Health Policy issues which

affect surgeons' practices in the state of Florida.

In October 2009, as a reflection of the American College of Surgeons' (ACS) support of local-level advocacy efforts by ACS Chapters in their respective states, the Board of Governors Committee on Chapter Relations (GCCR) considered a proposal requesting the development and implementation of a chapter advocacy grant program to help support a State Capitol Lobby Day. The Board of Regents approved this program in February 2010, and renewed it in February 2012. The program continues in 2017 and beyond, supporting Florida

surgeons' advocacy priorities in Tallahassee every year. Under this grant program, ACS chapters may apply annually for a grant for up to \$5,000 or an enhanced grant for \$15,000 in a given year.

This year, the Florida Chapter applied for the enhanced grant to better assist the Chapter and participating surgeons and trainees during our Advocacy Days held on January 30 and 31 during the 2018 Florida legislative session. At this session, we lobbied for our legislative priorities and trained Legislators in the Capitol Rotunda on the basic tenants of the ACS Stop the Bleed campaign. We have also developed a Joint Advocacy Committee (JAC) with the three ACS Chapters in the state of Florida to coordinate Florida surgeons' legislative priorities and resources—a major step to ensuring our success in advocacy and health policy for Florida surgeons in the future.

The Florida Chapter of the American College of Surgeons filled all six Delegate positions at the FMA Annual Meeting held in Orlando on August 4-6, 2017. Surgeons had the opportunity to network and seek consensus with our surgical priorities with FMA staff, County Medical Societies, Specialty Societies and with the entire House of Delegates. We look forward to working with the entire House of Medicine on our surgical priorities during that 2018 Florida legislative session.

The Advocacy Committee and Chapter Counsel are assembling the Advocacy Days agenda, scheduled for January 29-30 in Tallahassee. Please make every effort to attend this very important two days of surgical advocacy in Tallahassee. Please go to FCACS's website, floridafacs.org, for updates as this meeting approaches. +

Young Fellow Association Committee Update

The Young Fellow Association (YFA) Committee of the Florida Chapter has been active over the past months as we develop the vision for this group of members.

Prior to July 2017, the YFA members of the Florida Chapter had no formal activities for the early career surgeons within the state. As the chair of the committee, it is my goal to change this and position the committee to be a bridge between our very active resident members and the established leaders within the state.

This year, the YFA Committee had a very active presence at the FCACS Annual Meeting. Every year, new applicants for fellowship in the ACS apply with a deadline of December 1 for convocation at the following year's Clinical Congress. The applications are forwarded to the various

regional committees on applicants within each state (Florida has six). Applicants are then interviewed by committee members in the spring and final decisions on applicants are due to the ACS by May 15. This timeline positioned our Annual Meeting as a prime opportunity to serve as the meeting place for these interviews. The YFA committee took a leadership role in this process and interviewed over 40 potential fellows from Tampa, Orlando, and Jacksonville. After such success at the 2018 meeting, we look forward to expanding this opportunity for all districts in the coming years.

In addition to the applicant interviews, we also coordinated a mock oral exam for the PGY3, PGY4, and PGY5 resident members in attendance at the Annual Meeting. Adhering to our vision as mentors to this group, we saw this as an opportunity to increase the benefit of attendance for the residents while also serving as a networking

opportunity for the mock examiners. This increased interaction between established members and our young members will build the collegiality of our Chapter.
